

- 1. The Kingdom of Cambodia has received financing in the amount of US\$60 million equivalent from the World Bank toward the cost of the Cambodia Solid Waste and Plastic Management Improvement Project and it intend to apply part of the proceeds of this Loan to payments under the Contracts with 1 package was listed below:
 - a) REF No. MOI-G-04: Supply and Delivery of 2 Vehicles
- The goods are required by 30 calendar days from the date of contract signing.
- 3. Interested qualified eligible suppliers are invited to obtain a copy of the bidding documents free-of-charge from the address given below by submitting a written application. Except for the submission of a written application, there shall be no other conditions for obtaining the bidding documents.
- To be considered eligible and qualified a bidder must
 - (i) Meet the eligibility criteria of World Bank.
 - (ii) Have completed at least two contracts for supply of similar goods in the preceding 3 years of a value not less than 50% of estimate contract price].
 - (iii) Have completed contracts with a total cumulative value equal to at least two times estimated contract price in the preceding 2 years.
 - (iv) Not be under any notice of suspension or disbarment issued by the Government or World Bank.
- 5. Quotations must be delivered to the address given below on or before 10:00 AM on January 2, 2024. Late Quotations will be rejected. Quotations will be opened in public immediately thereafter at the address given below in the presence of the Bidders' representatives who choose to attend.
- 6. The Purchaser shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated quotation and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
- 7. All quotations must be accompanied by performance securing declaration as described in the bidding documents. Any quotation not accompanied by one will be rejected as non-compliant.

 - 9. The quotation must be submitted on or before **10:00 AM on January 2, 2024** at the following address: Ministry of Interior, Room No: 356, 3rd Floor, Preah Norodom Boulevard, Tonle Bassac, Chamkamon, Phnom Penh.
- 10. The Government and/or the Development Partner] will declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by the Government and/or the Development Partner respectively, if it at any time determines that the firm has engaged in fraud and corruption during the procurement and execution of this contract as described in ITB Clause 4.
- 11. A complaint may be made by any party at any stage of the procurement process. The procedure is described in Instructions to Bidders, Clause 21 of the Bidding Documents.
